

ORDINANCE NO. 2024- C

AN ORDINANCE OF CONEWAGO TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA, AMENDING CHAPTER 145, "VEHICLES AND TRAFFIC" OF THE CONEWAGO TOWNSHIP CODE TO ADD LOCATIONS WHERE PARKING WILL BE PROHIBITED AND CLARIFY NO PARKING IS ALLOWED WITHIN ANY FRONT, REAR, OR SIDE YARDS

WHEREAS, pursuant to 53 P.S. § 67328 of the Second Class Township Code, the Conewago Township ("Township") Board of Supervisors may adopt and amend ordinances from time to time that regulate parking to promote the convenience and protection of the public; and

WHEREAS, traffic and parking regulations have been held to be a valid exercise of police powers in the Commonwealth of Pennsylvania; and

WHEREAS, the Conewago Township Code ("Conewago Code"), Chapter 145, "Vehicles and Traffic," Article III, "Parking Regulations," Section 145-17 prescribes certain locations throughout the Township in which parking is prohibited at all times; and

WHEREAS, the Township has conducted a traffic study evaluating potential locations for additional parking restrictions; and

WHEREAS, the Board desires to further amend the Township's Chapter 145, Article III, parking regulations to further promote health, safety, and welfare in the Township by establishing additional no parking areas.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Conewago Township, Adams County, Pennsylvania, as follows:

SECTION 1. Amendments. Chapter 145, "Vehicles and Traffic," Article III, "Parking Regulations," Section 145-17, "Parking prohibited at all times in certain locations," of the Conewago Code is hereby amended in the following respects:

- A. Subsection "A" is amended to incorporate the following locations where parking shall be prohibited at all times:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Kindig Lane	Both	Entire length
North Madison Street	Both	Entire length
Oxford Avenue	East	From Kindig Land to Edgegrove Road

- B. Subsection "C" is amended to add the additional underlined text:

“Parking shall be prohibited in any area not defined as a parking space in § 145-1D. Parking within any front, rear, or side yards is prohibited.”

**SECTION 2. Repealer.** All ordinances or parts thereof inconsistent with the provisions of this Ordinance, including the previously adopted Chapter 145, “Vehicles and Traffic,” are hereby repealed.


**SECTION 3. Severability.** The provisions of this Ordinance are declared to be severable. If any provision of this Ordinance is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance.


**SECTION 4. Effective Date.** This Ordinance shall be effective immediately following its legal enactment.
